1. Call to order and Roll Call

2. <u>Approval of minutes from the March 6<sup>th</sup></u>, 2024 Annual Meeting (Appendix A)\*

A motion was duly made and seconded to approve the minutes of the March 6<sup>th</sup>, 2024 Annual Meeting. With no one opposed and one abstention, the minutes were approved.

Evelyn Powers presented and reviewed the summaries of the April 3<sup>rd</sup>, 2024 and May 7<sup>th</sup>, 2024 Executive Committee meetings (Appendix B and C).

- 3. <u>IEC Finances and Current Grant Funds Update</u>
  - a. Statement of Financial Activity and Balance Sheet (Appendices D and E)

Evelyn Powers and Treasurer Jeffrey Myers Reviewed the Statement of Financial Activity and Balance Sheet for YTD through March 31<sup>st</sup>, 2024. Evelyn Powers noted that YTD expenses overall at 62% of the anticipated, YTD budget. Line items particularly above budget include IT consultant (134%), Insurance (245%), Facility Repairs and Maintenance (272%). Many of these are items that are paid upfront at the beginning of the fiscal year and are anticipated to level out considerably over the second half of the year. Chair Scagnelli reported to the Commission on his review of the Commission's insurance policies, premiums, and limits. Chair Scagnelli reported that based on his review, and as reported to the Executive Committee, the insurance premiums and coverages were appropriate and necessary to protect the Commission. Chair Scagnelli and Evelyn Powers will follow up to ensure that there is no duplication of coverage particularly between the general liability and property policies. Evelyn will also review policies to ensure we are in compliance with the provisions of our lease. Jeffrey Myers reported the he and Evelyn reviewed the financials and may discuss changes in format to the financials.

b. Funding and Grants Update

Evelyn reviewed current and pending funding sources and balances as well as pending funding sources and grant applications.

Selvin will follow up with NYSDEC on the status of the 604b contract approval. The Commissioners also discussed PFAs monitoring in the region as it related to IEC's FY23 workplan which includes funding to support the development of PFAs analytical capability. Selvin Southwell noted that it is a concern in terms of both ambient monitoring and may be included in SPDES permits. Patricia Bisacky, CTDPH noted that EPA PFAS regulations related to drinking water will be enforced in Connecticut. Robert Schuster also noted that the NJDEP Division of Science and Research is looking at bioaccumulation factors for PFAS and should be releasing some information soon.

Evelyn Powers presented the Letter of Intent to Award in relation to a proposed contract with NYSDEC, contract C012976. The scope of work of the proposed contract includes administering federal, Bipartisan Infrastructure Law funds, which were awarded from the EPA Long Island Sound Office to NYSDEC. NYSDEC engaged IEC to assess IEC's interest and capability to administer the funds on behalf of NYSDEC. If awarded, the contract would involve entering into contracts with Nassau and Suffolk counties and administering reimbursements to Nassau and Suffolk for residential septic system replacements in the Long island Sound watershed. A

requirement of the Letter of Intent to Award is a resolution by the Commission identifying and authorizing the signatory for the contract on behalf of the Interstate Environmental Commission

\*Proposed Resolution: The Interstate Environmental Commission hereby authorizes and gives legal authority to Evelyn Powers, Executive Director, to sign contract C012976 (Appendix F) between the Interstate Environmental Commission and the New York State Department of Environmental Conservation on behalf of the Interstate Environmental Commission.

The Commission approved the authorizing resolution, with the stipulation set forth in the following motion made by Chair Scagnelli and seconded by Commissioner Trentman:

The Commission directs the Executive Committee to review Contract C012976 and determine whether the contract is acceptable to enter into with the New York State Department of Environmental Conservation.

With no one opposed, the resolution and motion were approved.

## 4. <u>Laboratory/Office Update</u>

a. Update on Staffing and Current Laboratory Operations

Evelyn Powers updated the Commission on operations and staffing. Five seasonal interns have been hired to assist with the monitoring season:

# 5. IEC FY24-25 Budget (Appendix G)\*

Evelyn presented the proposed FY2024-2025 Commission budget for the period October 1, 2024-September 2025 and distributed the following budget justification (Appendix G-1) during the meeting. IEC FY25 Budget Justification

The proposed FY25 Commission budget is derived from current grant budgets and projected grant award balances as of 10/1/2024. Federal funding sources include FY23 106 award in amount **of \$764,000**. Projected LIS FY21 project and grant balance of **\$292,977**. FY22 LIS Pathogen Monitoring

balance of **\$700,000**. Projected FY23 LIS base monitoring budget of **\$714,135** (approved by LIS Management Committee). Other sources: NYSDEC (LIS BIL Funding) Nassau/Suffolk county Septic System Replacement funding **\$2,062,500**, NYSDEC 604b funding **\$131,171**. NJDEP monitoring funds estimated at \$**370,488**, Save the Sound funds in amount of **\$44,145**, NPS funds in the amount of **\$4,735** and Research Foundation of CUNY (Brooklyn College) in amount of **\$116,000**.

Total Grant funds \$ 5,200,151 Total State Appropriations: \$133,000 Total Expenses (Budget): \$5,158,376.00 Total net income includes anticipated state appropriations (\$133,000) and amortized reimbursement of laboratory buildout (\$41,775)

# Budget supports 12.5 full-time equivalents (FTEs), 11.5 FTEs supported directly through grant funds; 1 FTE (administrative professional) through indirect (overhead).

A motion was duly made and seconded to approve the budget, pending Executive Committee approval of the proposed Long Island Sound Septic System Replacement Project contract C012976 with NYSDEC. With no one opposed the proposed budget was approved, pending approval of contract C012976.
